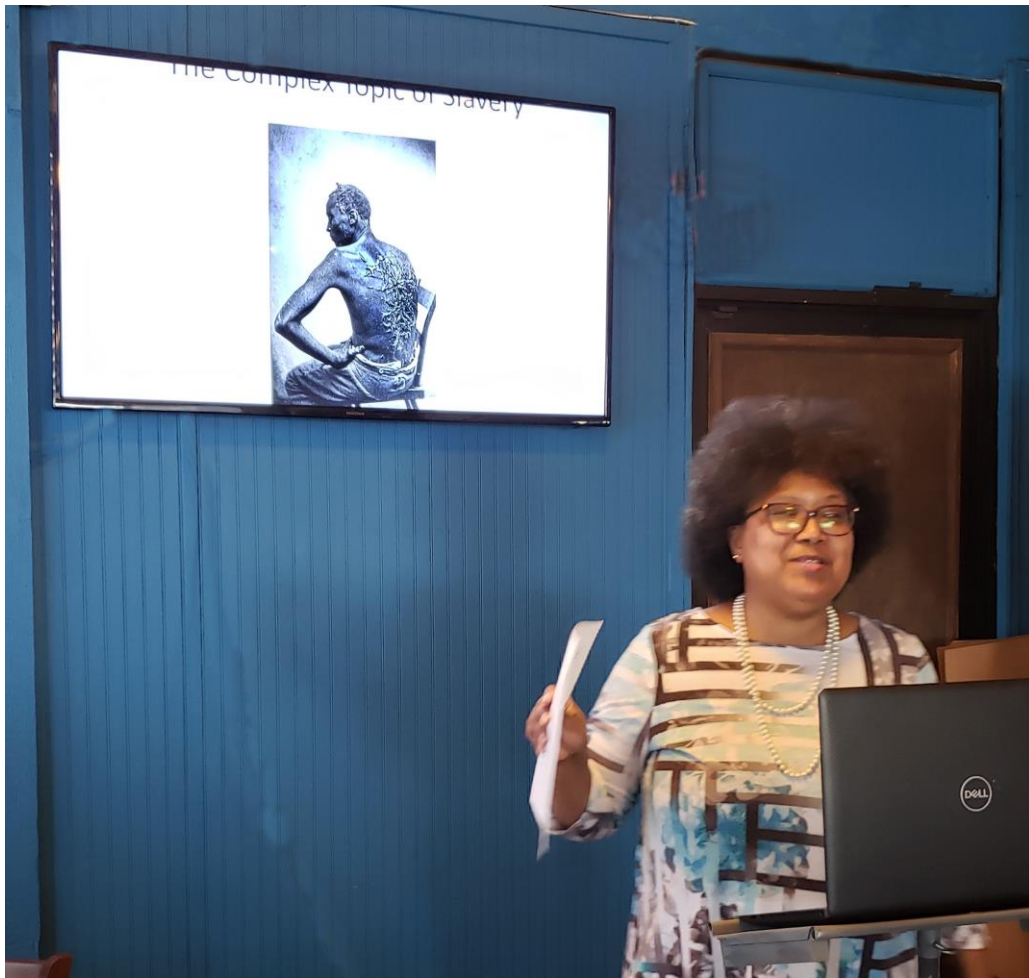

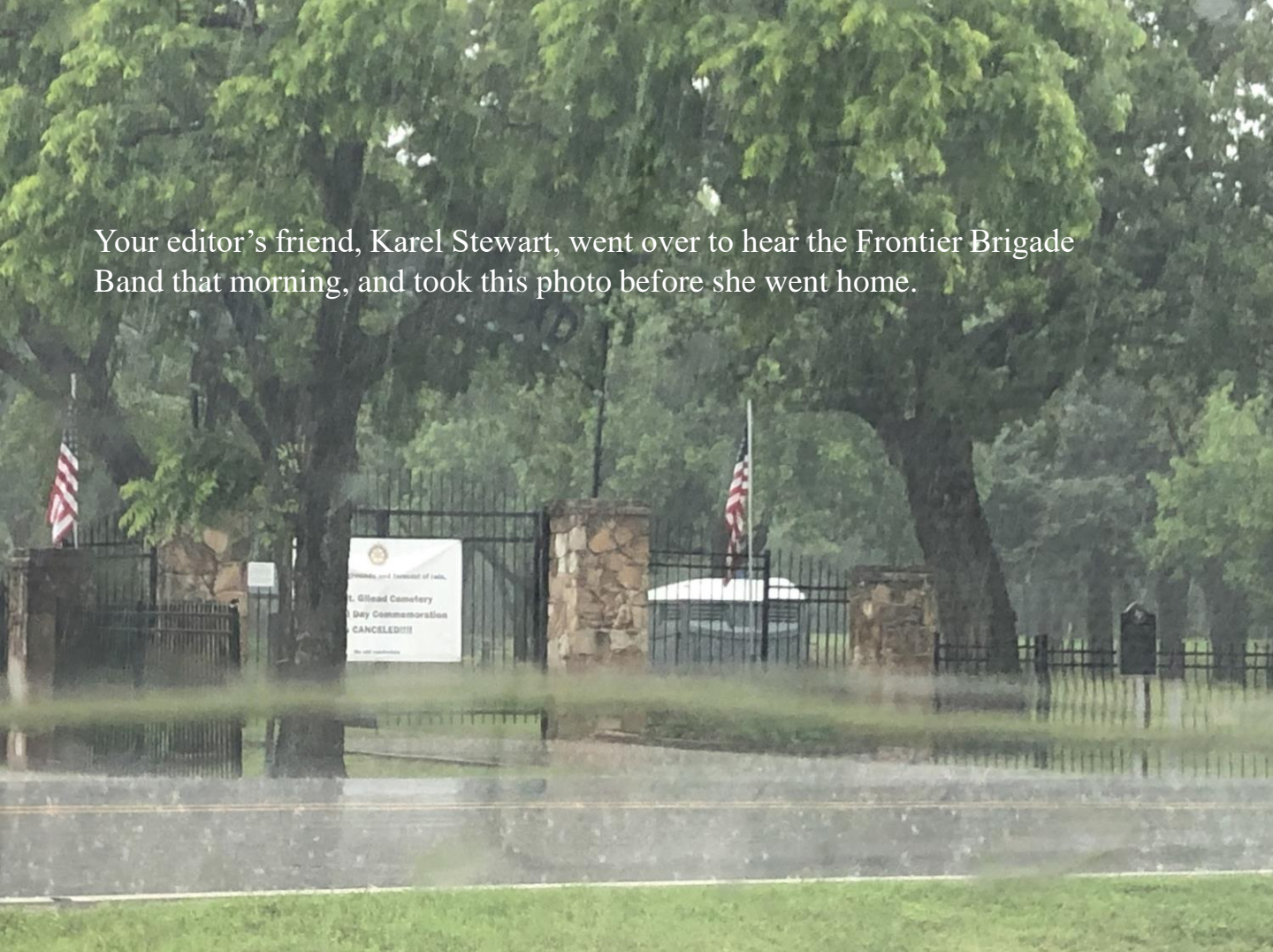
CONFEDERATE LIVES STILL MATTER

Meeting Minutes

Cmdr called for a Motion to Adjourn. Motion made by Ron Turner, second by Bobby Gresham. Meeting was adjourned at 7:40 pm

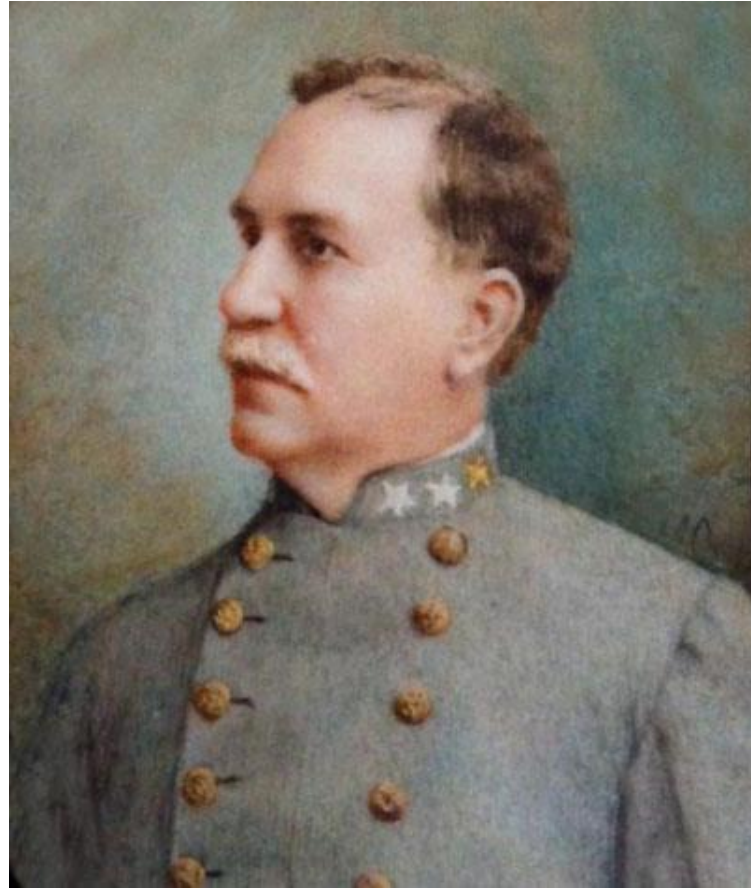
